The last revision of water and sanitary tariff was done by BWSSB on 01.02.2005. In the last 9 years no revision has been made for both domestic and non-domestic retail water consumption. In this last 9 years all the components of cost of production of water like staff salary, electricity charges, oil prices, consumables etc. have increased by more than double.

BWSSB is incurring high expenditure towards the power charges, Operation & Maintenance charges and other miscellaneous charges which are not possible to be borne through the current revenue that is being generated. Board in its letter cited under reference (1) had requested the Government of Karnataka for revision of water rates owing to increased expenditures. In response to this Government in its letter dated 12.11.2013 has directed the Board to take appropriate decision at the board level only.

The subject was placed before the board in its meeting held on 20<sup>th</sup> October 2014 highlighting all the aspects of revenue and the expenditure of the board and the dire necessity to increase the water tariff. Based on decision of the board and approval from the competent authority, this notification is being issued for the revision of water and sanitary rates in respect of all the consumer categories as per section 16 of Bangalore water supply and sewerage Act, 1964.
